

This guide contains all the information necessary to successfully capture live video content without any configuration – simply connect the cables and you're ready to go!

We'll start off by telling you about the product; giving you an overview, discussing the technical specifications, and more. Then we'll cover capturing video; providing a functional overview of how the product works, as well as some information on common resolutions, and third-party capture applications. Finally, we'll finish with a more detailed look at configuration, including advanced configuration options.

Let's get started!


Product overview

To use AV.io SDI+, there's no software to install; simply connect the cables and go. It works on Windows, Mac, and Linux and integrates seamlessly with your favorite third-party applications such as Teams, Zoom, OBS, Wirecast, vMix, VLC, and Quicktime.

What's in the box?

Your AV.io SDI+ product contains everything you need to easily capture live video content with minimal setup. Your purchase includes the following:

Hardware

This section describes the physical features of your AV.io SDI+, including diagrams and hardware feature descriptions.

Hardware diagrams

Your AV.io SDI+ device includes inputs, an output, and an indicator light.

Input/output ports and indicator lights are identified and explained in the top and bottom view images below. Indicator light details are explained in the following section.

Indicator LED details

The color of the indicator LED depends on whether you are receiving power from the USB port and whether or not a video source is connected to the input port. If the USB is plugged into a PC and there is no video source connected to the input the LED will be solid red. Once an active video input is detected the LED will turn solid white.

From the operating system's UVC drivers, the application will receive the AV.io SDI+ supported color space, resolution and frame rates. UVC stands for Universal Video Class and describes a type of USB device that uses standard drivers that come automatically installed on most operating systems.

LED color	USB/Input connection
Solid red	Power detected, no video input detected
Solid white	Power and active video input detected

Quick start

Setting up your AV.io SDI+ device to capture live video and audio content couldn't be easier!

Before you begin the connection process, you will require:

- An SDI video source (with or without audio)
- Your capture card device
- A capture desktop computer, laptop or notebook
- A USB cable (included with purchase) to connect your AV.io SDI+ to your capture computer
- An SDI cable (included with purchase) to connect your video source to your AV.io SDI+.

Once you have these things ready to go, you can now begin the simple process of hooking up your AV.io SDI+ so you can start capturing!

To connect your AV.io SDI+ for capture:

- 1. Connect your AV.io SDI+ device to your video source
- 2. Connect your AV.io SDI+ device to your computer
- 3. (Optional) Connect your audio device to the 3.5 mm audio input.
- 4. Open your favorite third-party application, select AV.io SDI+ from the list of available cameras and start capturing!

And that's it. No drivers to install and no extensive set-up. Just connect the cables and you're ready to go!

System requirements

System requirements are the barebones technical essentials your computer needs to work with AV.io SDI+. System requirements to use AV.io SDI+ include:

Video source	A 3G-SDI, HD-SDI or SD-SDI video source.
Video capture workstation	 Any computer (laptop/desktop/other format) with: a compatible USB 3.0 host controller for SuperSpeed operation; or,
	 a USB 2.0 host controller (will limit maximum frame rate and resolution support)
Video capture workstation operating system	Windows 7, Windows 10, and up Mac OS X 10.10 and up Linux distribution with kernel 3.5.0 or higher
Processor frequency	Minimum recommended value: 2.4 GHz
RAM	Minimum recommended value: 4 GB

Capture

Setting up your AV.io SDI+ device to capture live video content couldn't be easier!

Before you begin the connection process, you will require:

- An SDI video source (with or without audio)
- Your capture card device
- A capture desktop computer, laptop or notebook
- A USB cable (included with purchase) to connect to your AV.io SDI+ to your capture computer
- An SDI cable (included with purchase)to connect your video source to your AV.io SDI+.

Once you have these things ready to go, you can now begin the simple process of hooking up your AV.io SDI+ so you can start capturing!

How it works

Once you're ready to start capturing, you'll need either a built-in or third-party application to capture video and audio content with AV.io SDI+.

The application communicates with AV.io SDI+ and negotiates a **frame rate** (frequency at which frames in a video sequence are displayed) and **frame resolution** (size of a single video frame in pixels). A higher frame rate means smoother video capture while the frame resolution determines the aspect ratio of the video output as well as its dimensions and degree of definition.


With the help of AV.io SDI+, the content from your video source is automatically configured and captured on your computer through your selected application. If the application requests a frame size that is smaller or larger than your video source, AV.io SDI+ automatically scales the video for you. For consistent and widely compatible output, audio is automatically resampled to 16-bit 48 kHz stereo audio.

No configuration required!

Set up your device for capture

To connect your AV.io SDI+ for capture:

- 1. Connect your AV.io SDI+ device to your video source, ideally directly to the source, but some video sources may require special adapters
- 2. Connect your AV.io SDI+ device to your desktop computer, laptop, or notebook
- 3. Open your favorite third-party application, select AV.io SDI+ from the list of available input sources, and start capturing!



And that's it! No drivers to install and no extensive set-up! Just connect the cables and you're ready to go!

Resolutions, aspect ratios, and capture rates

The **resolution** (also known as frame size or display mode) of a video signal, digital image, TV screen, computer monitor or other display device is a count of the number of pixels displayed horizontally and vertically. For example the resolution 1920×1080 (which is 1080p) creates an image that is 1920 pixels wide and 1080 pixels tall.

The **aspect ratio** of an image describes the proportional relationship between its pixel width and height. The resolution 1920×1080 (1080p) is quite a bit wider than it is tall. The ratio of its width to height is 16 to 9, represented as an aspect ratio 16:9.

AV.io SDI+ outputs resolutions in commonly supported aspects ratios. The table below is a color-coded legend for interpreting the table of product resolutions below it:

Aspect Ratio	Common Use
4:3	Standard TV (NTSC/PAL) display and non-widescreen computer displays, SD-SDI resolution
16:9	Widescreen (HD) TV displays (1080p, 1080i, 720p etc.)

AV.io SDI+ generates a list of the following possible resolutions for your capture application to select for output display:

640×360	848×480	1024×768	1280×1024	1920×1080
640×480	960×540	1280×720	1600×1200	1920×1200

Captured video content is output to your application at **between 5 and 60 frames per second** (your application chooses one of these frame rates) when captured over USB 3.0. This table is not an exhaustive list of all the resolutions your AV.io SDI+ can output, just a list of common and tested resolutions.

Automatic image scaling & audio resampling


If your source content is larger or smaller than the frame size chosen by the application, AV.io SDI+ automatically **scales your source** to match the desired frame size. No user configuration required!

AV.io SDI+ also automatically performs **audio resampling**, meaning that no matter the bit depth or sampling frequency of audio through an SDI audio source, AV.io SDI+ automatically resamples your audio so that your application gets a consistent audio sample rate and bit depth, even if you change the video source.

Third-party applications

AV.io SDI+ uses pre-installed drivers on your OS (called **UVC drivers** and **UAC drivers**) to communicate with third-party applications and capture content. Due to AV.io SDI+'s use of UVC/UAC technology, there is no need for driver installation. Just like a webcam, your AV.io SDI+ device is immediately recognized as a camera device and can be used to capture content via any UVC-compatible third-party application.

Configuration

Your AV.io SDI+ device is ready to use right out of the box; however, there is support for additional configuration should you need it.

Firmware updates and changes to default capture settings can be applied to your AV.io SDI+ using Epiphan's AV.io+ Config tool. For settings to persist after power cycling, please allow 5 seconds before disconnecting or restarting the device.

You likely won't need to use the AV.io+ Config tool for more than firmware updates, but advanced settings can help you tweak the performance to get the most out of your AV.io SDI+.

Advanced configuration options include:

- Audio selector for audio inputs
- Modify Transfer Pipe
- Change the name of the device as it's seen by programs and operating system
- Set a custom UVC mode

Install the AV.io+ Config tool

Epiphan's AV.io+ Config tool is used for loading firmware updates on your AV.io SDI+ and for advanced settings changes.

You may install AV.io+ Config on the same computer(s) where you use AV.io SDI+, or only on one computer for configuration. All firmware updates and settings changes are saved to the device and work without any software installed on the computer. For settings to persist after power cycling, please allow 5 seconds before disconnecting or restarting device.

To install the AV.io+ Config tool, follow the directions below for your computer's operating system.

Windows


1. Download the AV.io+ Config package under the **Windows** heading on the AV.io SDI+ Downloads page on Epiphan's web site.

- 2. Extract all the files from the zip file (remember the location you're unzipping to).
- 3. Browse to the folder you unzipped to and open the AV.io+ Config tool by double-clicking on **EpiphanCaptureConfig.exe**. (Depending on your local security settings, you may need to right-click and choose to run the file as an administrator).
- 4. AV.io+ Config starts! If your AV.io SDI+ is connected to the computer by USB, it should be detected.

Update firmware using the AV.io+ Config tool

When new firmware is available, you can load this firmware onto your AV.io SDI+ using the AV.io+ Config tool and the steps below. If you register your product and agree to be notified of product updates, you'll receive an email when there is a firmware update available for download.



To update firmware using the AV.io+ Config tool:

- 1. If you haven't already done so, download and install the AV.io+ Config tool. See Install the AV.io+ Config tool.
- 2. Download the firmware update file from the Epiphan website, as described in your firmware update notification email or discussion with your vendor.
- 3. Connect your AV.io SDI+ device to your computer, laptop, or notebook.
- 4. Open the AV.io+ Config tool.

- 6. Using the diagram below, check the current firmware version of your AV.io SDI+. You can see the current version of the firmware in parenthesis next to the name of your device in the Config Tool. If it is the same version as the new firmware you downloaded, there is no need to do the firmware update.
- 7. If it isn't already selected click the Firmware tab

- 8. Click the **folder icon** to navigate to the saved location of the firmware, and click **Update** to update your video grabber to the selected firmware; an update bar appears and displays the progress of the update.
 - Please note, there will be two files in the compressed firmware file, a .bit and .img, perform this step with both files.

Do not disconnect your AV.io SDI+ at any point during the update process! Doing so may cause irrevocable errors and/or permanently damage the device.

9. When the update is finished the progress bar turns green and displays "Update Completed" (Note: the firmware update will not automatically be reflected in the Devices list unless the **Refresh** icon is clicked). You may now safely disconnect your AV.io SDI+ if needed.

When updating firmware on a Mac, the "Update Completed" text will not be displayed. The firmware upgrade is complete when the progress bar fills the width of the AV.io Config window and the window contents are no longer greyed out.

Identifying the input resolution

The AV.io Config tool can help you figure out exactly what information your video source is sending. Plug in the source and select your device. The UI detects information about the source and presents it at the bottom of the window.

The line tells you the exact resolution of the source (1920×1080p), and the frame rate the source is outputting (60 fps).

Advanced configuration options

The AV.io+ Config tool allows you to adjust several settings to make changes to your video capture experience if necessary. Most users won't need to use this utility for anything other than firmware updates, but advanced users may find these tweaks help them get the most out of their AV.io SDI+.

These options include:

- Select input for audio
- Modify Transfer Pipe
- Change the name of the device as it's seen by programs and operating system
- Set a custom UVC mode

The key descriptor used in the process of capturing SDI video using a UVC-based device is the UVC Descriptor.

UVC Descriptor: The UVC descriptor describes to the capture host computer which formats are available at the capture device USB port.

Select input for audio

Your AV.io SDI+ has a number of different audio input options, from ingesting audio from the main SDI input, to utilizing audio from the 3.5mm jack, or combining them. You can read more about the different audio modes in the Set the audio mode section.

Modify Transfer Pipe

Your AV.io SDI+ can modify the transfer pipe to increase compatibility with certain systems. The default option is Bulk, but if needed can be switched to Isochronous mode, if, for example, the PC to which your AV.io SDI+ is connected has lower performance or USB bandwidth availability. Please be aware that general performance may be lower in Isochronous mode. For more information check the Modify the transfer pipe section of the guide.

Change the name of the device as it's seen by programs and operating system

It's possible to change the device name of your AV.io SDI+ so that both your operating system and applications will identify and use the name you designate. This can be very useful when using multiple AV.io+ devices at the same time. You can learn more in the Change device name section of the guide.

Set a custom UVC mode

You are able to set a custom UVC mode when using your AV.io SDI+. What this means is that, using the AV.io+ Config tool, you can set a specific output resolution and frame rate so that applications are not able to request different values and must try to use the values that have been set. Learn more in the Set a custom UVC mode section of this guide.



Set the audio mode


The AV.io+ Config tool gives users the ability to specify a specific mode for audio output. For settings to persist after power cycling, please allow 5 seconds before disconnecting or restarting device.

To set the audio mode with the AV.io+ Config tool:

- 1. If needed, install the AV.io+ Config tool. For details specific to your OS, see Install the AV.io+ Config tool.
- 2. Connect your AV.io SDI+ device to your computer, laptop, or notebook.
- 3. Open the AV.io+ Config tool.



4. Select your AV.io SDI+ device from the list under the Devices heading.

- 6. To change the Audio input, click on the drop down menu and select from SDI, Mic In, Line In, SDI + Line In, or SDI + Mic In.
- 7. You can also adjust the volume of the input by moving the Volume slider to the left or right. Moving it all the way to the left will mute the audio source.





- 6. To set a custom device name, click in the Device name box and type in your desired name; then click Apply.
- 7. Navigate to the Device Manager in Windows and find the AV.io SDI+ with its previous name listed under **Cameras**, and **Sound**, **video**, **and game controllers**.
- 8. Right-click each entry and choose **Uninstall device**.
- 9. Once the devices have been uninstalled unplug the AV.io SDI+'s USB cable from the computer and then plug it back in.
- 10. Then click the **Scan** icon in the AV.io+ Config utility to confirm the changes.


